



6" THICK MINIMUM AGGREGATE BASE REQUIRED (#8 OR #57)
TO MINIMIZE ROOT ENCROACHMENT AND PREVENT DAMAGE TO THE WALK.

CONCRETE SPECIFICATIONS SHALL MEET OR EXCEED ODOT CLASS QC-MISC (ODOT ITEM 499)
ALL MATERIALS AND METHODS SHALL COMPLY WITH THE CURRENT OHIO DEPARTMENT OF TRANSPORTATION
(ODOT) MANUAL OF CONSTRUCTION SPECIFICATIONS

SAW JOINTS OR IMPRESSED JOINTS SHALL BE PROVIDED AT APPROVED DISTANCES NOT TO EXCEED 5' IN HORIZONTAL DISTANCE.

BROOM FINISH ALL SURFACES.

MINIMUM SLOPES BETWEEN THE SIDEWALK AND THE EDGE OF PAVEMENT MAY BE WAIVED IF UNUSUAL CONDITIONS EXIST AND THE AREA DRAINAGE IS ACCOUNTED FOR.

ALL FIXED OBJECTS WITHIN THE CONSTRUCTION LIMITS OF THE SIDEWALK SHALL BE ISOLATED FOR THE FULL DEPTH OF CONCRETE WITH APPROVED EXPANSION MATERIAL.

SIDEWALKS SHALL MEET AMERICAN WITH DISABILITIES ACT (ADA) REQUIREMENTS. SIDEWALK PEDESTRIAN RAMPS ARE REQUIRED AT ALL STREET INTERSECTIONS-RAMP DETAILS ARE AVAILABLE FROM THE CITY ENGINEER.

SIDEWALKS IN DRIVEWAYS AND WITHIN 5' OF DRIVEWAYS SHALL BE 6" THICK.
