RESOLUTION NO. 2023-01

A Resolution adopting rules for the conduct of City Council meetings for the 2024-2025 biennium.

RESOLUTION NO. 2023-02

A Resolution authorizing the sale, by internet auction during calendar year 2024, of City-owned personal property which is not needed for public use or which is obsolete or unfit for the use for which it was acquired; and declaring an emergency.

RESOLUTION NO. 2023-03

A Resolution of the City of Mount Vernon, Ohio supporting the Ohio Commission for the United States semiquincentennial (America 250-OH)..

RESOLUTION NO. 2023-04
