### RESOLUTION NO. 2024-37

A Resolution approving the PND comprehensive development plan as submitted by Lemmon Development and approved by the Mount Vernon Municipal Planning Commission for parcel #71-00050.000 on Upper Gilchrist Road; and declaring an emergency.
