RESOLUTION NO. 2024-17

A Resolution authorizing the Safety-Service Director to advertise for bids and enter into contract for the Mansfield Avenue sidepath project (KNO-CR5-0.47 PID 115280); and declaring an emergency.

RESOLUTION NO. 2025-18
